Terms and Conditions

I, the party named below, in consideration of the acceptance of my registration to participate in the activities of the TEXAS ASSOCIATION OF SINGLE SAILORS, INC. (TASS), for myself, my heirs, executors, and administrators, do at this moment RELEASE and DISCHARGE the association known as TASS. All individual members, including but not limited to the vessels' skippers and crew, who are in any way connected with these activities, from any claims of damage, injury, demands, or actions whatsoever in any manner arising out of my participation in said events. I also verify that I am physically fit to participate in said event. I further verify that I will not possess, hold, or consume any illegal or contraband substances while on any TASS sail or aboard any vessel which has been chartered for a TASS activity.

I have read, understand, and agree to abide by the above statements.

Cancellation / Refund Policy

Unless otherwise noted in the Event Payment Details, per the current By-Laws of TASS Article 3.3 FEES & REFUNDS, as of 4-1-2017:

(Please note that it does not say "credit policy." The By-Laws have no provision for issuing credits.)

TASS policy is no refunds for any fees or deposits paid toward sailing or other activities unless an Officer of TASS or the TASS Skipper in charge of the sail cancels that sail or activity. According to the regulations in the By-Laws, Article 3.2, a member may find a replacement for TASS sails WITH approval from a TASS Officer or Skipper.

To obtain your refund, you need to contact the TASS Treasurer by email at treasurer@sailtass.com

IF A SAIL or EVENT IS CANCELLED (refunds will ONLY be made IF TASS CANCELS the event or sail)

Refunds will be made as follows:

- (1) If paid by Credit Card via the web payment system, the cardholder will be issued a credit to the card of the original payment charge. This refund will not appear in your member account.
- (2) If paid by cash or check, the Treasurer will send you a refund check or pay your refund in cash. (Please note that checks will be sent to your current address as listed in the membership directory, so please make sure your information is current and that you HAVE checked the box at the bottom to SHARE MY INFORMATION, which ONLY shares it within TASS)

Photo waiver:

I understand that TASS takes and reuses photographs from sails and events that I may appear in, and these may be used on the TASS website, Facebook, social media, and other promotional purposes. I authorize TASS to publish photographs taken of me for use in TASS's printed publications and website.

I acknowledge that since my participation in publications and websites produced by TASS is voluntary, I will receive no financial compensation.

I understand that TASS sails only in Clear Lake and Galveston Bay, Texas, and does not sail outside of this area or in other states or countries.

I release TASS, its board members, and its members from liability for any claims by me or any third party concerning my participation.

I understand that TASS is a non-profit organization and that the use of photographs will be limited to educational, non-commercial purposes. I represent that I am over eighteen, have read the policy, and understand the contents thereof.
